This certificate attests to the product performance of fire reaction and that all provisions concerning the assessment and verification of constancy of performance described in the harmonized reference technical specification:

EN 14041 : 2004

Are applied and that the product fulfills all the prescribed requirements.

Product fire reaction performance: C_{fl} – s1, valid when bonded to any A2-s1,d0 or A1 rated substrate whose thickness is \geq 6 mm and whose density is \geq 1350 kg/m³.

This certificate can only be used in conjunction with the declaration of performance of the product written by the manufacturer or his authorised representative established in the European economic area and with the technical specification in reference.

This certificate is issued on 10th of December 2015, it cancels and replaces the certificate previously delivered on 3rd of March 2015 and, except for withdrawal or suspension, remains valid as long as the conditions laid down in the corresponding technical specification in reference or the manufacturing conditions in the factory or the factory production control itself are not modified significantly.
